If ZOOBILEE does not receive payment of any monthly invoiceby the fifteenth (15th) day of the month, ZOOBILEE will send you a reminder via e-mail. If ZOOBILEE does not receive payment of any invoice by the twentieth (20th) day of the month, ZOOBILEE will terminate access to your account and withhold access to your account information, together with any and all other legal and equitable remedies ZOOBILEE may have for nonpayment of your invoice.
